## **TERMS OF USE**

The use of 'We', 'Us' or 'Our' refers to Ramsay Health Care UK Operations Limited ('Ramsay'), and any group in the entity as applicable.

The use of 'You' or 'Your' refers to any person who has been invited to use the electronic Multi-Disciplinary Team (eMDT) system, provided by Context MDM Limited ('Context Health').

# 1. By Using Context Health You Accept these Terms

- a. These Terms of Use are legally binding and apply to your access to and use of Context Health.
- b. By using Context Health you confirm that you accept these Terms of Use and that you agree to comply with them.
- c. We recommend you print a copy of these Terms of Use for future reference.

# 3. In these Terms of Use:

- a. The CONTEXT Meeting Platform means the web-based management software and associated infrastructure provided by Context Health designed to help health and care providers to conduct electronic Multi-Disciplinary Team (eMDT) Meetings.
- b. Ramsay invites you to use the CONTEXT Meeting Platform to conduct eMDT Meetings in accordance with:
  - i. NICE Multidisciplinary Team Meetings, NICE Guideline 94, March 2018<sup>1</sup>
  - ii. NHS Streamlining Multi-Disciplinary Team Meetings, 2020<sup>2</sup>
  - iii. Paterson Inquiry, Report of the Independent Inquiry into the Issues raised by Paterson, February 2020<sup>3</sup>

- d. You will be deemed to have agreed to any such modification or amendment to these Terms of Use by your use of the CONTEXT Meeting Platform following the date in which the modified or amended Terms of Use are posted in the "Terms of Use" link.

# 5. Requirements for Context Health

- a. Context Health requires your computer, telephone, internet access, device and associated equipment to meet certain technical levels (System Requirements) in order to access the CONTEXT Meeting Platform. Ramsay takes no responsibility for problems associated with or arising from your inability to access the CONTEXT Meeting Platform due to your equipment or internet speed not meeting the System Requirements.
- b. Use of Context Health may require the use of audio-visual peripherals (visual displays, web cameras microphones/speakers or headsets) that are compatible with your device and operational.

# 6. Your use of Context Health

- a. You may only use Context Health and access the CONTEXT Meeting Platform if you have been provided permission or have been invited by an authorised user.
- b. You are able to invite colleagues from other healthcare providers to contribute to an eMDT meeting using a Context Health invite link. You must ensure that any colleague you invite to provide an opinion has the necessary licenses and registrations in place and a legitimate purpose for contributing.
- c. You may be subject to additional terms of use in relation to the services provided via Context Health by Ramsay or third parties. If you decide to use these services, you will be responsible for reviewing and understanding the terms associated with these services.
- d. Should you become aware of any known breach or compromise of the system you must notify Ramsay's Data Protection Officer without delay at:

- e. You must ensure the confidentiality and security of data held within the system is maintained at all times when accessing the system. Your Context Health account details must remain secure at all times and passwords should not be stored on any device used to access the CONTEXT Meeting Platform.



- f. For security purposes, please ensure that all software and operating system updates are installed on the device used to access the CONTEXT Meeting Platform. You must not access the CONTEXT Meeting Platform from a publicly accessible device.
- g. Any data held within the CONTEXT Meeting Platform must not be copied, downloaded, stored, or retained on your device.
- h. You must ensure that any data uploaded to the CONTEXT Meeting Platform is appropriate and has legitimate grounds under applicable data protection legislation to be shared.
- i. We reserve the right to monitor the use of the CONTEXT Meeting Platform and to terminate your access to the CONTEXT Meeting Platform if you fail to comply with these Terms of Use.

# 7. We are not responsible for viruses and you must not introduce them

- a. We do not guarantee that the CONTEXT Meeting Platform will be free from bugs or viruses.
- b. You are responsible for configuring your own technology and access to the CONTEXT Meeting Platform.
- c. You must not misuse the CONTEXT Meeting Platform by knowingly introduce viruses. When uploading any attachments, ensure content has been checked for viruses.

  specifications.

The CONTEXT Meeting Platform is delivered by CONTEXT MDM Limited ('Context Health'). Ramsay is the controller for the purposes of Data Protection Legislation and Context Health is the processor.

This document describes how Ramsay and our processors collect, use, disclose and store your personal information when you use or access the CONTEXT Meeting Platform.

## 1. TYPE OF PERSONAL DATA WE COLLECT

To create an account, Context Health, on behalf of Ramsay, may collect:

- First name, last name
- Role
- Phone number
- Email address
- Primary institution
- Professional Registration Number

## 2. USING YOUR PERSONAL DATA AND THE LEGAL BASIS FOR PROCESSING

Ramsay's legal basis for processing your personal data under the General Data Protection Regulations (the 'GDPR'):

• Article 6 (1)(f) - the processing is necessary for an organisation's legitimate interests or the legitimate interests of a third party.

We process this data for the following purposes:

- Provide you with access to the CONTEXT Meeting Platform;
- Improve the quality of services and develop new ones;
- Deliver information and messages to you that have been created in reference to Cases or eMDT Meetings that you are associated with on the CONTEXT Meeting Platform;
- Improve security by protecting against fraud and/or abuse and preserve any forensic details for investigation if required; and
- Conduct analytics and measurement to understand how the Context Health services are used. Information within the CONTEXT Meeting Platform will also be supplied to Context



Health's Customer's Services Teams that measure how the services and the CONTEXT Meeting Platform are used.

## 3. CONTEXT Meeting Platform Utilisation

Context Health will combine data among their services and across your devices for these purposes. For example, depending on your account settings, aggregate data will be collected through your inputs that may relate to eMDT Meetings. This data may be used for comparative measurement of the service offered.

Utilisation and use of services will be compared, such as Video and Meeting Duration to inform service provisions. This may include comparison of data use across the provisioned services.

## 4. DATA RETENTION

Any personal information you enter is retained for the duration of your live account and in accordance with our retention schedule.

## 5. DATA SECURITY

Ramsay is committed to ensuring the privacy and confidentiality of your personal information within its control. Although the transmission of information via the internet is never completely secure, we will use our best endeavours to protect your information from loss, misuse or alteration when it is within our control in compliance with all applicable Data Protection Legislation. We may also share your personal information with data processors who are third parties who provide elements of services for us. We will only disclose personal information that is necessary for them to provide the service that they are undertaking on our behalf. We have contracts in place with our data processors, to ensure that they only handle your information in accordance with our instruction. They will hold it securely and retain it for the period we instruct.
