## TERMS OF USE



#### IQemo – RAMSAY HEALTH CARE UK AUTHORISED USERS

The use of 'We', 'Us' or 'Our' refers to Ramsay Health Care UK Operations Limited ('Ramsay'), and any group in the entity as applicable.

The use of 'You' or 'Your' refers to any person who has been invited to use the cloud based system, provided by IQ Healthcare Limited ('iQemo).

### 1. By Using IQemo You Accept these Terms

- a) These Terms of Use are legally binding and apply to your access to and use of IQemo.
- b) By using IQemo you confirm that you accept these Terms of Use and that you agree to comply with them.
- c) We recommend you print a copy of these Terms of Use for future reference.

#### 3. In these Terms of Use:

- a) iQemo has developed and provides a cloud-based chemotherapy e-prescribing, dispensing and nursing administration system that enables health care professionals to securely prescribe their patients chemotherapy from any location with an internet connection based on pre-configured regimes.
- b) Ramsay invites you to use the iQemo platform to view patient's treatment to assist your consultant(s) to work safely and effectively and in accordance with Ramsay policy:
  - a. <u>CMM-017 Policy for the Safe Prescribing Handling and Administration of</u> <u>Systemic Anti-Cancer Therapies (SACT)</u>

The IQemo Platform is delivered by IQ Healthtech Limited ('IQemo'). Ramsay is the controller for the purposes of Data Protection Legislation and IQemo is the processor for the purposes of Data Protection Legislation.

# 1. TYPE OF PERSONAL DATA WE COLLECT

To access create an account IQemo, on behalf of Ramsay, may collect:

- your first name, last name;
- your phone number;
- email address; and
- Professional Membership number (PIN/GPhC ect).

### 2. USING YOUR PERSONAL DATA AND THE LEGAL BASIS FOR PROCESSING

Ramsay's legal basis for processing your personal data under the General Data Protection Regulations (the 'GDPR'):

We process this data for the following purposes:

Although the transmission of information via the internet is never completely secure, we will use our best endeavours to protect your information from loss, misuse or alteration when it is within our control in compliance with all applicable Data Protection Legislation. We may also share your personal information with data processors who are third parties who provide elements of services for us. We will only disclose personal information that is necessary for them to provide the service that they are undertaking on our behalf. We have contracts in place with our data processors, to ensure that they only handle your information in accordance with our instruction. They will hold it securely and retain it for the period we instruct.
